Summerfield Youth Council Accepts Town Funds but Refuses to Open Books for Inspection

Youth organization run by Councilwoman Dianne Laughlin and Councilman Bob Williams daughter, Kim Jackson, hires attorney when asked for financial disclosure.

The Summerfield Youth Council (SYC), a local non-profit organization (now a not-so non-profit; more on this later), was established in 2003 by former town clerk, Dianne Laughlin, and Michael Garrett, son of School Board member Darlene Garrett. Since 2003, the SYC's address of record has been 4117 Oak Ridge Rd, Summerfield NC. The official contact phone and fax numbers were and remain 643-8655 and 643-8654, respectively. Some might think twice about establishing a non-profit business at town hall, but this was apparently not a problem for Laughlin (town clerk) and Garrett. Subsidized at taxpayer expense, no-cost shared facilities and resources (phone/fax) have been a huge benefit

to the SYC. But the perks don't end here...

Since 2003, council members Dena Barnes, Mark Brown, Bob Williams, and now Dianne Laughlin herself have showered the SYC with praise, privilege, and taxpayer funds. Councilman Williams recently volunteered from behind the council table that the SYC's exclusive, profit sharing, agreements with the town are the organization's main source of income for the year. Until a little over a year ago, at every council meeting, the SYC had a special time slot reserved just for their representative to speak.

When the IRS revoked the SYC's non-profit status last year, we thought it would be interesting to take a look at how they had been spending all that money. Per IRS rules, a non-profit is obligated to open its books for inspection when asked. We sent registered letters to Garrett, Laughlin, and executive director of the SYC, Kim Jackson (who happens to also be Councilman Williams daughter), asking them for a time certain to meet at town hall and inspect their documents. None of them have responded. Instead they hired an attorney. Its been over two months and we're still waiting to inspect the SYC records. At this point we are starting to believe Laughlin, Jackson, or Garrett do not have any intent to comply. \diamond

Committee, you know someone had to foot the bill. In this case that would be you, the Summerfield taxpayer.

You spent \$1,813, plus the cost of Town employee time, paying for the Oceans Eleven entertainment event. Dividing the cost by the 25 people who came, you paid around \$72 a head for others to watch a decade old rerun. According to the best information we can gather, it appears that eleven of the 25 movie goers were town employees and their spouses. Employees and their spouses were not eligible for the advertised promotional giveaways, some of which you also paid for.

Giveaways? Yes, giveaways. The Summerfield Parks and Recreation promoted the event as "Dinner – Movie – Games of Chance." Scratch off cards were given out to movie attendees (not necessarily to Summerfield citizens). Prizes included a pair of \$25 in gas cards and one \$50 certificate for dinner at PF Chang's...all of which you paid for. You might also find it interesting to know that the scratch off cards themselves were crafted by paid town employees, adding yet another cost to the "free" movie you helped pay for. �

More than once, often multiple times at the same location, signs for candidates Alicia Flowers, Elizabeth McClellan, Jane Wilson, and Don Wendelken have been wiped out. Signs just across the street for the opposing candidates are left untouched.

Frustrated with the fact that their signs were selectively stolen (on some nights well over 100 signs), candidates Alicia Flowers, Elizabeth McClellan, Jane Wilson, and Don Wendelken are offering a \$1000 reward for information leading to the arrest and conviction of persons stealing their property.

Flowers, McClellan, Wilson, and Wendelken have all filed stolen property reports with the Guilford County Sheriff's department. Some property owners have also filed reports of unauthorized trespassing. Flowers, McClellan, Wilson, and Wendelken are asking you to call the Sheriff at 373-2222 or Crimestopers at 202-0488 if you have any information on who is stealing signs and freedom of speech in Summerfield *****
