June 19, 2008 (regular Summerfield meeting continued from June 10, 2008)

Business from Council: Update from committee chair meeting regarding volunteers and ethics statement

Wray stated he asked for it to be brought back to council because he is unhappy with the term limit provisions and feels it is inappropriate to ask about bankruptcies.

July 8, 2008 (regular Summerfield council meeting)

Volunteer application discussion

Requirement for volunteers to disclose bankruptcies removed (even though many, many, volunteers had signed form w/o any issues/complaints)

Suggestion that all applicants be subject to same background checks fails.

Motion passes, 3 to 2 (Wray, Williams, and Barnes for stripping disclosure/Flowers & Strickland for keeping disclosure)

July 15, 2008

Thomas Valent, director of sponsorships, Summerfield Recreation Association, arrested for embezzlement from that organization

Oct 14, 2008 (regular Summerfield council meeting)
