Steve Adkins called the meeting to order at 7:00 pm. He stated that this was an exploratory meeting intended to gauge interest in the formation of a group of citizens who are pro Summerfield, and judging by the turnout and the number of regrets he received, there is definitely an interest. He also cited several reasons as being the catalyst for forming this group. Such reasons included abuse of FOIA requests, town staff resignations, opposition to Phase II of the Summerfield Park and baseball field issues.

Conclusions:

The goal for this meeting was to establish a core leadership group, name a spokesperson for the group, set up a regular meeting time, collect names and a distribution email list, establish priorities, and to establish a code of conduct.

Discussion:					

Steve presented some preliminary ground rules and asked for comments and suggestions. Kim Jackson stated that she felt like the News and Record should not be excluded when it came to coverage/advertising for the group. Others (including Northwest Observer staff) agreed that the N&R readership would help us to reach more people. Steve said that he was researching 501c3 organizations and it might be necessary to become a formal organization of some type in the future.

Conclusions:

Attendees were all in agreement that the group should focus on the positive and be open and honest with the media. It was decided to use both the NWO and the N&R as publicity vehicles.

Discussion:			

Steve presented a few ideas for issues to be supported by this group along with some issues that we find offensive and are detrimental to Summerfield. He asked for input/additions from the attendees.

- Debbie Hoffman felt it was important to give positive alternatives to any negativity expressed at town council meetings.
- Jane Doggett asked if we wanted to advocate for more parks after Phase II is complete. Jay Copeland stated that the piece of land being looked at for ball fields offered room for growth and this was a possibility for more park land. - Debbie Hoffman asked if we should address the Town Core issue again. Jane said that the Comprehensive plan should take care of that. Jane did say that she felt the PUD issue should be pushed. Jim Flynt stated that PUD ordinances usually only applied to large tracts of land and there weren't that many left. He also stated that the greatest issue in the NW communities was sprawl and he felt that nothing was being done to address this.
- Troy Stanliff wanted to see water brought back to the forefront. Sue Beeson stated that she felt that voter apathy was a huge issue.
- Jane Doggett stated that she would like for us to ask the town council to address the issue of welcome signs again.
- Leon Stokes asked if the purpose of this group was to speak with one voice and the attendees agreed. Leon also stated that he felt that mailings made a big difference.
- Jay Copeland stated that it was inappropriate for town council members to allow personal feelings and agendas to interfere with council business. He did not like the way some town council members had addressed speakers in the past.
